- OUTLETS REQUIRING 24 HR. AND/OR DEDICATED CIRCUITS ARE DOUBLE LIST PRICE.
- EQUIPMENT HOOK-UPS, REPAIRS AND INSTALLATIONS WILL BE PERFORMED ON A LABOR AND MATERIAL BASIS.
- THERE IS A MINIMUM LABOR CHARGE OF (1) HOUR TO DELIVER POWER TO ALL ISLAND BOOTHS. ALL ADDITIONAL DISTRIBUTION IS DONE BY CONVENTION ELECTRICAL SERVICES ELECTRICIANS ON A TIME & MATERIAL BASIS

GENERAL INFORMATION

- ALL OUTLETS WILL BE INSTALLED ON THE FLOOR AT THE REAR OF THE BOOTH. ISLAND AND PENINSULA BOOTH OUTLETS WILL BE BROUGHT TO ONE (1) LOCATION AT OUR DISCRETION IF NO INFORMATION IS PROVIDED.
- ALL WIRING, MOTORS AND OTHER INSTALLATIONS MUST BE APPROVED, TO PREVENT OVER-LOADING OF CIRCUITS. EXHIBITORS ARE NOT PERMITTED TO ADD WATTAGE UNLESS ORDERED. EXHIBITORS FOUND USING OUTLETS WITHOUT AN ORDER WILL BE SUBJECT TO PAY THE REGULAR PRICE FOR OUTLETS USED.
- ALL ELECTRICAL PERMITS REQUIRED BY THE LOCAL BUILDING AND SAFETY CODES WILL BE OBTAINED BY THE ELECTRICAL CONTRACTOR. ALL EQUIPMENT MUST MEET SAFETY CODE REGULATIONS, INCLUDING MOTORS, WIRING, EXTENSION CORDS, ETC.
- LABOR RATES ARE SUBJECT TO LOCAL I.B.E.W. UNION CONTRACT EFFECTIVE AT TIME OF SHOW. OVERTIME LABOR RATES PREVAIL PRIOR TO 8:00 A.M. AND AFTER 3:30 P.M. ON WEEKDAYS, AND ALL DAY SATURDAYS, SUNDAYS AND HOLIDAYS.

PAYMENT POLICY

- 100% PAYMENT MUST ACCOMPANY EACH ORDER UNLESS PRIOR ARRANGEMENTS ARE MADE.
- WE ACCEPT CASH, CHECKS, MASTERCARD, VISA, DISCOVER AND AMERICAN EXPRESS FOR PAYMENT.
- ADVANCE PRICES APPLY ONLY TO ORDERS RECEIVED AT LEAST 10 DAYS PRIOR TO THE FIRST SHOW MOVE-IN DATE, ALL OTHER ORDERS WILL PAY REGULAR PRICES.
- ORDERS PLACED AT THE SHOW SITE MUST BE PAID UPON PRESENTATION OF INVOICE.
- NO REFUND WILL BE GIVEN FOR OUTLETS INSTALLED AND/OR SERVICES PROVIDED AND NOT USED. CLAIMS WILL NOT BE CONSIDERED UNLESS FILED BY THE EXHIBITOR PRIOR TO THE CLOSING OF THE SHOW.

For your protection you should install a surge protector on your computer(s). All electrical installations and connections to all electrical service should be made by a Convention Electrical Services, Inc. electrician.

Convention Electrical Services, Inc. will not be responsible for any damage or loss to any equipment, component, computer hardware or software and/or any damage or injury to any persons caused by the installation, connection or plugging into any electrical outlet by any persons other than a Convention Electrical Services electrician.

REGULATION AND GENERAL INFORMATION

- 1) Payment must be included with your order to secure the advance rate. Please see the "Electrical Order Form" for the advance rate cutoff date. A photocopy of the check will not be accepted to receive the advance rate.
- 2) You need to designate one location for each outlet ordered. There is a 500 watt minimum. All outlets will be installed on the floor at the rear of the booth unless otherwise noted.
- 3) Island booths are required to submit a detailed floor plan with your order. A separate outlet must be ordered for each location where an electrical service is required. If floor plan does not show the main power location prior to CES move-in date CES will bring the main power to convenient location at CES discretion. All distribution will be done on a time and material basis.
- 4) All wiring and other installations will be performed on a time and material basis.
- 5) Check rating plates on your equipment to ensure you will have proper power to operate your display.
- 6) If overhead lights are ordered and we must hang them from a ceiling at a convention center or hotel then lift charges will be applied. Labor charges will also be applied.
- 7) All wiring must have a 3-wire grounded cord with a minimum of #14 gauge.
- 8) Dedicated and 24 hour power will be at double the list price. Please indicate these requirements on your floor plan or order form.
- 9) All labor requests require a credit card on file.
- 10) Labor before 8:00 am and after 4:30 pm and on Saturdays, Sundays, and holidays will be at the overtime rate.
- 11) Lift rates: \$125.00 per hour (One hour minimum)
- 12) No credits will be issued on unused outlets or lights installed as ordered.
- 13) Exhibitors found using outlets without an order will be subject to the regular rate for outlets used.
- 14) Electricity will be turned on within 30 minutes of show opening and off within 30 minutes of show closing, show days only.
- 15) If Convention Electrical Services is required to bill you a 25% handling charges will be applied to all outstanding balances due. A service charge of 1.5% per month will be applied to balances not paid after 10 days of invoice date.
- 16) CES jurisdiction: All under carpet distribution of electrical wiring. All facility overhead distribution of electrical wiring including coaxial cable, fiber optics, twisted pair etc., and the distribution of same form product to booth and from booth to booth.
